### **Option 4)**

**OFSTED Ready Audit and Action Plan (Centre based; 1 to 1 support)**

**School Based Review (Single School)**

We will conduct a review of Teaching, Learning and Assessment using an established Post 16 Audit Tool. The Review will be honest but developmental and provide realistic actions for improvement.

The Review will cover:

- Prospectus and other marketing materials
- Historic review data of performance around recruitment, retention, attainment and progression
- Views of Learners and Teachers
- Review of assessments, feedback and marked work
- Extra-curricular
- Learning walks
- Potential for collaboration
- The aggregate response will help determine the nature of Leadership and management in the school

Audit will include the new DFE Accountability Measures

Post 16 Action Plan – mirroring the current OFSTED Requirements for school sixth form improvement. Practical steps for improvement.
